Manufacturing Georgia trending upward

The 2015 Georgia Manufacturers Register reports that Georgia now has more than 1,000 manufacturing companies who employ almost 500,000 Georgians – an increase from early 2013. Georgia manufacturers added 3,833 industrial jobs from May 2013 to May 2014.

Tom Dubin, president of the Evanston, IL-based publishing company notes, "The state's low business costs and top-notch infrastructure continue to draw investment and support industrial growth."

Two of the latest manufacturing announcements are in ECG communities, Dalton and LaFayette.

IVC U.S. in Dalton

Luxury vinyl tile (LVT) is a hot ticket right now in the flooring industry and IVC U.S. of the Belgium-based IVC Group, is building a new \$80 million plant at its Dalton complex to produce the product. The investment will include new equipment and establish a state-of-the-art production environment for the LVT product line of planks and tile. The new line is an expansion of the existing 500,000 square foot facility.

IVC will administer Georgia's Quick Start, our state's topranked workforce training program, to train the 200 new employees who are to be hired over the next five years.

Georgia has the fifth lowest manufacturing unionization rates in the U.S.

Georgia's John Zegers, Director, Center of Innovation for Manufacturing, anticipates 2015 will be a good year for manufacturing as reported in *Industry Week Magazine*. He outlines six key predictions for manufacturing for the year.

#5 Increased investment in capital equipment

Improved bottom lines will drive replacement of aging legacy equipment and investment in new capital equipment that performs better, more efficiently and more reliably. Software will also assist in making current equipment more efficient.

In recent history, manufacturing jobs moved from domestic locations to global markets, and much of the collective knowledge left with those jobs, with fewer people training in skilled manufacturing. There has been a shift of emphasis

away from technical training.

Now, as more companies are on-shoring their manufacturing facilities because of energy costs and political uncertainty, companies are placing more importance on workforce, reprioritizing it as a top five factor in their site selection decision.

What are states offering prospects?

Most state training programs reimburse some cost of training new employees. Many jurisdictions offer cash grants to offset training costs and while cash incentives sound like a great idea, compliance related to obtaining the funding may be overly burdensome.

The most successful and well-known training programs offered are those that allow for specialization. Georgia's Quick Start program is a great example.

For jurisdictions desiring to be part of a site selection conversation, an emphasis needs to be placed on keeping the costs of doing business low and strengthening the existing workforce.

What does a Georgia College and Career Academy (CCA) look like?

The answer to this question is simple yet varied because a CCA is a reflection of its community. Some models include multiple high schools within a single school district, some are across multiple school systems and for smaller communities it may be single high school. While the models may vary they all:

- 1. reflect local workforce needs; prepare students for careers as well as college
- 2. offer dual credit courses for high school and college
- 3. are a collaboration among a school system, local technical college, local industry and civic organizations
- 4. are run by CEOs
- 5. are chartered by the State Department of Education
- 6. have received a one time multi-million dollar facility grant from the CCA program.

Industry Vision

It would be great if our local students could begin their welding education as high school sophmores.

Result

Fifty-five students graduated in 2014 from Newnan's Central Educational Center with a high school and welding degree. Starting salary in Coweta County for welders averages \$21 an hour.

CA SUCCESS Argeted student training

A young woman attends high school, CCA and works part-time. She graduates with a high school and criminal justice associate degree and is debt free. Next stop: University of Georgia followed by law school.

A West Georgia Technical College student jump starts her certified nursing program with a certified nursing assistant certification in hand because of dual enrollment through LaGrange's fledgling CCA.

more fresh workforce ideas

- The Fort Valley Workforce Development Center is a satellite center of Central Technical College. Partners Peach County Board of Commissioners and the Development Authority of Peach County will offer GED and skill specific training in its new facility.
- Our own energy industry is looking at workforce needs with a "Get Into Energy" initiative. For example, MAGIC* Summer Camp is a free, one-week, day camp that offers high school girls the opportunity to learn about the construction industry.

Community Development Acworth uses firm to assess hotel options

Acworth is an old hand at extending hospitality, serving travelers with restaurants, shopping and lodging since the early 1900s. Acworth's Main Street was a segment of the Old Dixie Highway, the first paved highway which was built between 1915-1925 to traverse north and south from Miami, FL to the Canadian border. Motor courts and hotels prospered along the route until the completion of Interstate 75 in the 1970s prompted a shift in travel patterns.

Acworth today is taking a more strategic approach to locating a hotel within its city limits.

"Hotels are considered an important economic component to any community. The assessment of where and what hotel model requires an evaluation of the economic benefits of the initial investment both in the short-term and over the long-term," explains ECG retail expert Mill Graves.



Acworth opted to engage a professional firm to do a hotel study for the community. The final 120-page document addresses many things including direct impact (projected revenues), projected taxes related to a hotel's operations and the eco-Blanching Co. nomic effects generated when employees consume goods peanut product **exporter** and services in the community.

Ben Hill County This type of market analysis may also mitigate costs for the incoming developer. Typically feasibility studies can cost a developer upwards of \$20-30,000 and are a critical part of the developer's due diligence in the beginning stages of the development process and initial pro forma. Communities interested in recruiting hotel prospects can reduce some of the barriers to hotel development by completing similar market analyses.

\$5MM Investment USDA loan & grant in Hogansville

The City of Hogansville will soon begin construction of significant sewerage system upgrades, made possible with more than \$5 million in loan and grant Water and Environmental Programs (WEP) funding. Upgrades include improvements to the treatment system, expansion of the treatment capacity



from 0.65 mgd to 1.5 mgd, and conversion of the effluent disposal from land application system to a direct discharge system.

The WEP provides loans, grants and loan guarantees for drinking water, sanitary sewer, solid waste and storm drainage facilities in rural areas and cities and towns of 10,000 or less.

This program is just one initiative from the USDA. Its Rural Development program offers loans, grants and loan guarantees to support essential services such as housing, economic development, health care, first responder services and equipment, and water, electric and communications infrastructure.


