Application Period: through 5/4/21

Type: Grant

The Community Food Projects Competitive Grant Program (CFPCGP) has existed since 1996 as a program to fight food insecurity through developing community food projects that help promote the self-sufficiency of low-income communities. Community Food Projects are designed to increase food security in communities by bringing the whole food system together to assess strengths, establish linkages, and create systems that improve the self-reliance of community members over their food needs.

U.S. Department of Agriculture (USDA) Rural Development

Community Facilities Direct Loan & Grant Program

Application Period: through 12/31/21

Type: Loan or Grant

This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings.

Rural areas including cities, villages, townships and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census data are eligible for this program.

Funds can be used to purchase, construct, and / or improve essential community facilities, purchase equipment and pay related project expenses.

Examples of essential community facilities include:

- Health care facilities such as hospitals, medical clinics, dental clinics, nursing homes or assisted living facilities
- Public facilities such as town halls, courthouses, airport hangars or street improvements
- Community support services such as child care centers, community centers, fairgrounds or transitional housing
- Public safety services such as fire departments, police stations, prisons, police vehicles, fire trucks, public works vehicles or equipment
- Educational services such as museums, libraries or private schools
- Utility services such as telemedicine or distance learning equipment
- Local food systems such as community gardens, food pantries, community kitchens, food banks, food hubs or greenhouses.

Rural Business Development Grants (RBDG)

This program is designed to provide technical assistance and training for small rural businesses. Small means that the business has fewer than 50 new workers and less than \$1 million in gross revenue.

Many large-scale, surface transportation projects - highway, transit, railroad, intermodal freight, and port access - are eligible for assistance. Eligible applicants include state and local governments, transit agencies, railroad companies, special authorities, special districts, and private entities. The TIFIA credit program is designed to fill market gaps and leverage substantial private co-investment by providing supplemental and subordinate capital. Business development revolving loan funds (RLFs) are pools of money used by grantees for the purpose of making loans to create and retain jobs. As loans are repaid, money is returned to the fund and made available for additional loans. Distressed County Grants

Application Period: ongoing

Type: Grant

ARC awards grants to projects that address one or more of the five goals identified by ARC in its strategic plan and that can demonstrate measurable results. The five goals identified by ARC are Business Development and Entrepreneurship, Education and Training, Health Care, Physical Infrastructure, and Leadership Development and Civic Capacity. ARC targets special resources to the most economically distressed counties in the Region, using a measure of economic distress based on three economic indicators: three-year average unemployment rates, per capita market income, and poverty rates. Besides allocating funding to benefit distressed counties, ARC has established other policies to reduce economic distress. ARC normally limits its maximum project funding contribution to 50 percent of costs, but it can increase its funding share to as much as 80 percent in distressed counties. Georgia Department of Community Affairs (DCA)

Downtown Development Revolving Loan Fund (DDRLF)

Application Period: ongoing

Type: Grant to Lenders (grants for DDAs to lend to businesses)

The purpose of the Downtown Development Revolving Loan Fund (DD RLF) is to assist cities, counties and development authorities in their efforts to revitalize and enhance downtown areas by providing below-market rate financing to fund capital projects in core historic downtown areas and adjacent historic neighborhoods where DD RLF will spur commercial redevelopment. Eligible applicants under this program shall be municipalities with a population of 100,000 or less, counties with a population of 100,000 or less proposing projects in a core historic commercial area, and development authorities proposing projects in a core historic commercial area in municipalities or counties with a population of 100,000 or less. State Small Business Credit Initiative (SSBCI)

Application Period: ongoing

Type: Loan

The Small Business Jobs Act of 2010 (the "Act") became law in the fall of 2010. The Act created the State Small Business Credit Initiative, funded with \$1.5 billion to strengthen state lending programs that support small businesses and manufacturers. Of the total amount funded, Georgia was allocated \$48,024,748. Currently, Georgia's SSBCI offers two programs. GA LPP (Georgia Loan Participation Program) is a program where the State purchases a participation of up to 25% of an approved loan, for loans ranging from \$100,000 to \$5,000,000. (Maximum participation amount depending on program liquidity) Current Maximum participation is \$250,000.

Georgia SBCG (Small Business Credit Guaranty) is a 50% loan guaranty program with a current maximum loan amount of \$400,000 with a \$200,000 guarantee.

EDGE Fund (OneGeorgia Authority)

Application Period: ongoing

Type: Grant or Loan

The purpose of the EDGE Fund is to provide financial assistance to eligible applicants that are being considered as a relocation or expansion site and are competing with another state for location of a project; and, where the EDGE Fund is used when the health, welfare, safety and economic security of the citizens of the state are promoted through the development and/or retention of employment opportunities. Equity Fund (OneGeorgia Authority)

Application Period: ongoing

Type: Grant or Loan

Regional Economic Business Assistance (REBA)

Application Period: ongoing

Type: Grant or Loan

REBA is an incentive program that is used to help "close the deal" when companies are considering Georgia and another state or country for their location or expansion. REBA funds may be used to finance various fixed-asset needs of a company including infrastructure, real estate acquisition, construction, or machinery and equipment. A local development authority must be the applicant for a REBA application and the application must be supported by a recommendation letter from a state agency, typically the Georgia Department of Economic Development.

Employment Incentive Program

Application Period: ongoing

Type: Loan

The Employment Incentive Program (EIP) is a financing program that may be used in conjunction with traditional private financing for economic development projects resulting in employment of low- and moderate-income persons.

Many types of public infrastructure projects, or loans to for-profit companies, can be financed with EIP funding. Projects creating opportunities for low- and moderate-income persons (*at least 51% of total jobs created*), greater job security, better working conditions, job training, enhancement of workplace skills, advancement opportunities, and benefits receive the greatest consideration. Immediate Threat and Danger Program (CDBG)

Application Period: ongoing

Type: Grant

The Immediate Threat and Danger Program provides 50% matching funds for community development activities having a particular urgency when existing conditions pose a serious and immediate threat to the health or welfare of the community. Local funds must comprise at least 10% of project costs. Funding for this program comes from the state's annual Community Development Block Grant (CDBG) program. Applicants can apply for \$50,000 and DCA reserves \$200,000 for "major disasters."

Eligible applicants are units of general purpose local government, excluding metropolitan cities, urban counties, and units of government eligible to participate in the urban counties or metropolitan cities program of the U.S. Department of Housing and Urban Development. The ITAD Program is intended to address situations which are urgent and unique. **These situations should typically occur due to state or federally declared disasters.** These funds are not available for repairs of public infrastructure that are failing due age and lack of maintenance or the general "wear and tear" on existing infrastructure. Some examples of urgent and unique problems include:

- Acquisition of property located in a flood plain that was severely damaged by a recent flood
- Demolition of structures that were severely damaged by a major earthquake or tornado To be fundable, applications must address an event or situation having a particular urgency and uniqueness that adversely affects a community and its citizens and where other financial resources are not available to meet such needs. The event or situation must have a sense of urgency and be of recent origin or have recently become urgent. Recent origin is defined as a condition that developed or became critical within 18 months of application. CDBG Section 108 Loan Guarantee Program

Application Period: ongoing

Type: Loan Guarantee

The CDBG Section 108 Loan Guarantee Program is an economic and community development financing tool authorized under Section 108 of Title I of the Housing and Community Development Act of 1974, as amended. The program is a method of assisting non-entitlement local governments with certain unique and large-scale economic development projects that cannot proceed without the loan guarantee. In order to be eligible a project must meet all applicable CDBG requirements and result in significant employment and/or benefit for low and moderate income persons. Projects that are eligible for financing under existing federal, state, regional or local programs will generally not be considered for guarantee assistance unless the programs would fail to fully meet a project's need.

Unlike the traditional CDBG or EIP Program, the Section 108 Program does not operate through assistance from the Department of Community Affairs (DCA). Rather, funds are raised through DCA's "Pledge of Grants" to the U.S. Department of Housing and Urban Development (HUD) in order to obtain a federal guarantee of notes issued by the local government. The federally guaranteed notes are sold into private markets through public offerings conducted by HUD. By approving the project, the State pledges its future CDBG funds as the ultimate repayment source should a Section 108 loan default. The State's participation in the Section 108 program does not involve a pledge of Georgia's full faith and credit nor does it commit any funding to the local government. HUD makes the ultimate approval or denial of the federal guarantee. Since CDBG funds are an essential and critical resource for Georgia's non-entitlement local governments, the Department will use conservative rating, selection and underwriting criteria in evaluating requests for the State's concurrence and Pledge of Grants. Only those projects that DCA determines can generate sufficient revenue from local and project resources to debt service all obligations will be competitive under the State's Section 108 rating and selection system. Maximum Loan Guarantee Amount: \$5,000,000 (In the interest of limiting exposure and promoting a diversified portfolio, the Department reserves the right to limit the amounts "pledged" to any one unit of local government or business interest).

Annual CDBG Competition

Application Period: through 6/4/21

Type: Grant

The Community Development Block Grant Program (CDBG) provides funding to assist a wide range of eligible activities, including housing improvement projects, public facilities such as water and sewer lines, buildings such as local health centers or head start centers, and economic development projects. All projects must substantially benefit low and moderate income persons.

The maximum amount available per applicant is \$750,000 for Single-Activity during regular competition and \$1,000,000 for Multi-Activity during regular competition. Local Match Requirements - Annual Competition:

- Grants up to \$300,000, or grants for single activity housing projects no matching funds required.
- Grants of \$300,001 to \$750,000 5% local matching funds required.
- Grants of more than \$750,001 10% local matching funds required.

Eligible applicants are units of general local government, excluding metropolitan cities, urban counties, and units of government eligible to participate in the urban counties or metropolitan cities programs of the U.S. Department of Housing and Urban Development. Eligible applicants selected for funding will be those having the greatest need as evidenced by poverty and per capita income and whose applications most adequately address the needs of low and moderate income persons and have the greatest impact.

Renaissance Strategic Visioning and Planning Process (RSVP)

Application Period: ongoing

Type: Technical Assistance

The Downtown Renaissance Strategic Visioning and Planning Process assists downtowns through the creation of a community-supported vision, plan, and implementation program. The RSVP is both a downtown master planning process and a downtown planning document that illustrates the community's vision for the future and provides the steps to get there.
