



U.S. Department of Agriculture (USDA) Rural Development

Community Facilities Direct Loan & Grant Program

Application Period: through 12/31/21

Type: Loan or Grant

This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings. Rural areas including cities, villages, townships and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census data are eligible for this program. Funds can be used to purchase, construct, and / or improve essential community facilities, purchase equipment and pay related project expenses.

Rural Business Development Grants (RBDG)

Application Period: ongoing

Type: Grant

This program is designed to provide technical assistance and training for small rural businesses. Small means that the business has fewer than 50 new workers and less than \$1 million in gross

Application Period: ongoing

Type: Loan or Grant

This program is designed to provide loans and grants to Microenterprise Development Organizations (MDOs) to:

- To help microenterprises startup and growth through a Rural Microloan Revolving Fund.
- Provide training and technical assistance to microloan borrowers and micro entrepreneurs

Intermediary Relending Program (IRP)

Application Period: ongoing

Type: Loan

This program provides 1 percent low-interest loans to local lenders or "intermediaries" that relend to businesses to improve economic conditions and create jobs in rural communities.

Local Food Promotion Program

Application Period: 5/12/21-6/21/21 Type: Grant (25% match required)

The Local Food Promotion Program (LFPP) funds projects that develop, coordinate, and expand local and regional food business enterprises that engage as intermediaries in indirect producer to consumer marketing to help increase access to and availability of locally and regionally produced agricultural products. Grants can be used for the planning stages of establishing or expanding a local and regional food business enterprise or to improve or expand a food business that supports locally and regionally produced agricultural products and food system infrastructure by performing feasibility studies, market research, training and technical assistance for the business enterprise and/or for producers working with the business enterprise. Entities that are eligible to apply include: Agricultural businesses and cooperatives; Community Supported Agriculture (CSA) networks and associations; Food councils; Economic development corporations; Local governments; Nonprofit and public benefit corporations; Producer networks or associations; Regional farmers' market authorities; Tribal governments.

Farmers Market Promotion Program

Application Period: 5/12/21-6/21/21 Type: Grant (25% match required)

The Farmers Market Promotion Program (FMPP) funds projects that develop, coordinate and expand direct producer-to-consumer markets to help increase access to and availability of locally and regionally produced agricultural products by developing, coordinating, expanding, and providing outreach, training, and technical assistance to domestic farmers markets, roadside stands, community-supported agriculture programs, agritourism activities, online sales or other direct producer-to-consumer (including direct producer-to-retail, direct producer-to-restaurant and direct producer-to-institutional marketing) market opportunities. Entities that are eligible to apply include: Agricultural businesses and cooperatives; Community Supported Agriculture (CSA) networks and associations; Food councils; Economic development corporations; Local governments; Nonprofit and public benefit corporations; Producer networks or associations; Regional farmers' market authorities; Tribal governments.

U.S. Department of Justice (DOJ)

Law Enforcement Mental Health and Wellness Act (LEMHWA) Program

Application Period: 4/29/21-6/3/21

Type: Grant

The Fiscal Year 2021 Law Enforcement Mental Health and Wellness Act (LEMHWA) program funds are used to improve the delivery of and access to mental health and wellness services for law enforcement through training and technical assistance, demonstration projects, and implementation of promising practices related to peer mentoring mental health and wellness programs. The 2021 LEMHWA program will fund projects that develop knowledge, increase awareness of effective mental health and wellness strategies, increase the skills and abilities of law enforcement, and increase the number of law enforcement agencies and relevant stakeholders using peer mentoring programs. This program is open to all local, state, tribal, and territorial law enforcement agencies.

Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP)

Application Period: Through 6/7/21

Type: Grant

The Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) was developed as part of the Comprehensive Addiction and Recovery Act (CARA) legislation. COSSAP aims to reduce the impact of opioids, stimulants, and other substances on individuals and communities, including a reduction in the number of overdose fatalities, as well as mitigate the impacts on crime victims by supporting comprehensive, collaborative initiatives. This opportunity provides funding to develop, implement, or expand comprehensive programs in response to illicit opioids, stimulants, or other substances of abuse.

Eligible applicants are: City governments; County governments; Native American tribal governments (Federally recognized)

Rural Violent Crime Reduction Initiative for Law Enforcement Agencies

Application Period: 5/19/21-7/6/21

Type: Grant

The Rural Violent Crime Reduction Initiative is awarding grants on a competitive basis to small law enforcement agencies and prosecutors' offices in rural locations. These grants will support improved training and technology, expanded community-based crime prevention programs, and partnerships with victim services providers. This initiative is intended to improve communication and collaboration between state, local, and tribal law enforcement agencies and the communities they serve in order to address the unique criminal justice challenges in rural areas. Eligible applicants are: City governments; County governments; Native American tribal governments (Federally recognized). This solicitation is limited to agencies serving rural communities. To qualify as rural for the purposes of this solicitation, an applicant must provide services in a rural area, although the jurisdiction's service area need not be exclusively rural. This definition holds for all entity types. COPS Hiring Program (CHP)

Application Period: 5/7/21-6/15/21

Type: Grant

The COPS Hiring Program (CHP) is a competitive grant program designed to provide funding directly to law enforcement agencies to hire and/or rehire additional career law enforcement officers in an effort to increase their community policing capacity and crime prevention efforts. Anticipated outcomes of the CHP program awards include engagement in planned community partnerships, implementation of projects to analyze and assess problems, implementation of changes to personnel and agency management in support of community policing, and increased capacity of agency to engage in community policing activities.

Funding under this program may be used to do the following:

- Hire new officers, which includes filling existing officer vacancies that are no longer funded in your agency's budget.
- Rehire officers laid off by any jurisdiction as a result of state, local, or Bureau of Indian Affairs (BIA) budget reductions.
- Rehire officers who are (at the time of application) currently scheduled to be laid off by your jurisdiction on a specific future date as a result of state, local, or BIA budget reductions.

All state, local, and tribal law enforcement agencies that have primary law enforcement authority are eligible to apply.

Community Policing Development (CPD) Microgrants Program

Application Period: 5/26/21-7/8/21

Type: Grant

The Community Policing Development (CPD) Microgrants funds are used to develop the capacity of law enforcement to implement community policing strategies by providing guidance on promising practices through the development and testing of innovative strategies, building knowledge about effective practices and outcomes, and supporting new, creative approaches to preventing crime and promoting safe communities.

Applicants are invited to propose demonstration or pilot projects to be implemented in their agency that offer creative ideas to advance crime fighting, community engagement, problem solving, or organizational changes to support community policing in one of the following areas:

- Community Trust and Legitimacy
- Officer Engagement
- Youth Engagement
- Hate Crimes and Domestic Terrorism
- Community Violence Intervention

When applying, please be sure to select the most appropriate subcategory under which to apply. Please note that applicants may submit multiple applications, but you must submit a separate application for each project. Any application that does not clearly state the solicitation, and where applicable, the subcategory on the cover page of the project narrative (if applicable) or selects the incorrect subcategory may not pass the basic minimum requirement phase of the review process. Byrne Criminal Justice Innovation Program

Type: Grant

The U.S. Department of Justice (DOJ) is seeking applications for funding a strategic approach to crime reduction that leverages community knowledge and expertise to build public trust with law enforcement and make neighborhoods safer. This program furthers the Department's mission by leading efforts to enhance the capacity of local and tribal communities to effectively target and address serious and violent crime issues through collaborative cross-sector approaches that help advance broader neighborhood development goals.

Eligible applicants are: City or township governments; County governments; Native American tribal governments (Federally recognized); Native American tribal organizations (other than Federally recognized tribal governments); Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education; Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education; Private institutions of higher education; Public and State controlled institutions of higher education

Patrick Leahy Bulletproof Vest Partnership

Application Period: Through 6/14/21

Type: Grant

The Patrick Leahy Bulletproof Vest Partnership (BVP), created by the Bulletproof Vest Partnership Grant Act of 1998 is a unique U.S. Department of Justice initiative designed to provide a critical resource to state and local law enforcement. Grantees are required to keep documentation to support the BVP vest application and payment requests for at least a three year period. Cities, counties, states, Indian tribes and special government districts are eligible applicants. Your jurisdiction is eligible to apply for funding if it is a recognized unit of general government and it employs eligible law enforcement officers.

Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grants

Application Period: 4/15/21-7/12/21

Type: Grant

National Infrastructure Investments are now known as Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grants, formerly TIGER and BUILD Transportation Grants. RAISE Grants are for capital investments in surface transportation that will have a significant local or regional impact. Eligible Applicants for RAISE grants are State, local, Tribal, and U.S. territories' governments, including transit agencies, port authorities, metropolitan planning organizations (MPOs), and other political subdivisions of State or local governments.

U.S. Department of Transportation (DOT) Build America Bureau

Transportation Infrastructure Finance & Innovation Act of 1998 (TIFIA)

Application Period: ongoing

Type: Loan

The Transportation Infrastructure Finance and Innovation Act (TIFIA) program provides credit assistance for qualified projects of regional and national significance. Many large-scale, surface transportation projects - highway, transit, railroad, intermodal freight, and port access - are eligible for assistance. Eligible applicants include state and local governments, transit agencies, railroad companies, special authorities, special districts, and private entities. The TIFIA credit program is designed to fill market gaps and leverage substantial private co-investment by providing supplemental and subordinate capital. Transportation Infrastructure Finance & Innovation Act (TIFIA) Rural Project Initiative (RPI)

Application Period: ongoing

Type: Loan

The Rural Project Initiative is aimed at helping improve transportation infrastructure in America's rural communities. Eligible projects include:

- Roads, bridges and tunnels,
- Transit systems including infrastructure, bus and train stations, and buses and passenger rail vehicles and facilities
- Intermodal connectors,
- Pedestrian and bicycle infrastructure,
- · Freight transfer facilities,
- Sea and inland waterway ports, and even,
- Airports under certain circumstances.

U.S. Department of Commerce National Telecommunications and Information Administration (NTIA)

Broadband Infrastructure Program

Application Period: 5/19/21-8/17/21

Type: Grants

The Broadband Infrastructure Program makes grants on a competitive basis to covered partnerships for covered broadband projects. A covered partnership may include more than one provider of fixed broadband service as part of its application. Additionally, a provider of fixed broadband service may participate in more than one covered partnership. A provider of broadband service that is part of a covered partnership is not required to be designated as an eligible telecommunications carrier pursuant to section 214(e) of the Communications Act of 1934 (47 U.S.C. 214(e)). NTIA encourages municipalities, non-profits, or cooperatives that own and/or operate broadband networks to participate in this program as part of a covered partnership. NTIA's Broadband Infrastructure Program was established by the Consolidated Appropriations Act, 2021. In the priority order defined by the Act, NTIA will accept applications for projects that are designed to:

- Provide broadband service to the greatest number of households in an eligible service area
- Provide broadband service to rural areas
- Be most cost-effective in providing broadband service, or
- Provide broadband service with a download speed of at least 100 Mbps and an upload speed of at least 20 Mbps.

NTIA will group applications based on the priority above that each application addresses, and will sequence its review of application groups in the statutory order listed above.

NTIA is holding a series of webinars to further inform stakeholders about the program. The next Broadband Infrastructure webinars will be held on June 9 and 10.

Internal Revenue Service (IRS)

Volunteer Income Tax Assistance (VITA) Grant

Application Period: 5/4/21-6/4/21

Type: Grant

The Volunteer Income Tax Assistance (VITA) grant program is an IRS initiative designed to support free tax preparation service for the underserved through various partner organizations. This service helps low- to moderate-income individuals, persons with disabilities, the elderly, and limited English speakers file their taxes each year. IRS awards matching funds to these support organizations that offer free tax preparation services during the tax filing season at locations in all 50 states and the District of Columbia.

Applicants must already be classified as one of the following:

- A private or public non-profit organization that qualified for and received an IRS
 determination letter confirming the organization's tax exemption under section 501 of the
 Internal Revenue Code, including but not limited to credit unions and faith based and
 community organizations
- A public, nonprofit, or proprietary (privately owned profit-making) college, university, vocational school, or other postsecondary educational institution located in the United States and Puerto Rico that has not been disqualified from participating in a student aid program administered by the U.S. Department of Education
- A local government agency
- A federally recognized Indian Tribal government, or
- A regional, statewide, or local coalition with one lead organization that meets one of the eligibility requirements noted above. The lead organization filing the application must have a substantive role in the coalition.
- This grant requires 100% cost sharing or matching of all federal funds awarded.

Appalachian Regional Commission (ARC)

Business Development Revolving Loan Fund Grants

Application Period: ongoing Type: Grant to Lenders

Business development revolving loan funds (RLFs) are pools of money used by grantees for the purpose of making loans to create and retain jobs. As loans are repaid, money is returned to the fund and made available for additional loans. Applicants must be within the ARC region.

Distressed County Grants

Application Period: ongoing

Type: Grant

ARC awards grants to projects that address one or more of the five goals identified by ARC in its strategic plan and that can demonstrate measurable results. The five goals identified by ARC are Business Development and Entrepreneurship, Education and Training, Health Care, Physical Infrastructure, and Leadership Development and Civic Capacity. ARC targets special resources to the most economically distressed counties in the Region, using a measure of economic distress based on three economic indicators: three-year average unemployment rates, per capita market income, and poverty rates. Besides allocating funding to benefit distressed counties, ARC has established other policies to reduce economic distress. ARC normally limits its maximum project funding contribution to 50 percent of costs, but it can increase its funding share to as much as 80 percent in distressed counties. Georgia Department of Community Affairs (DCA)

Downtown Development Revolving Loan Fund (DDRLF)

Application Period: ongoing

Type: Grant to Lenders (grants for DDAs to lend to businesses)

The purpose of the Downtown Development Revolving Loan Fund (DD RLF) is to assist cities, counties and development authorities in their efforts to revitalize and enhance downtown areas by providing below-market rate financing to fund capital projects in core historic downtown areas and adjacent historic neighborhoods where DD RLF will spur commercial redevelopment. Eligible applicants under this program shall be municipalities with a population of 100,000 or less, counties with a population of 100,000 or less proposing projects in a core historic commercial area, and development authorities proposing projects in a core historic commercial area in municipalities or counties with a population of 100,000 or less. The ultimate user of funds may be a private business or a public entity such as a city or development authority.

State Small Business Credit Initiative (SSBCI)

Application Period: ongoing

Type: Loan

The Small Business Jobs Act of 2010 (the "Act") became law in the fall of 2010. The Act created the State Small Business Credit Initiative, funded with \$1.5 billion to strengthen state lending programs that support small businesses and manufacturers. Of the total amount funded, Georgia was allocated \$48,024,748. Currently, Georgia's SSBCI offers two programs.

GA LPP (Georgia Loan Participation Program) is a program where the State purchases a participation of up to 25% of an approved loan, for loans ranging from \$100,000 to \$5,000,000. (Maximum participation amount depending on program liquidity) Current Maximum participation is \$250,000.

Georgia SBCG (Small Business Credit Guaranty) is a 50% loan guaranty program with a current maximum loan amount of \$400,000 with a \$200,000 guarantee.

EDGE Fund (OneGeorgia Authority)

Application Period: ongoing

Type: Grant or Loan

The purpose of the EDGE Fund is to provide financial assistance to eligible applicants that are being considered as a relocation or expansion site and are competing with another state for location of a project; and, where the EDGE Fund is used when the health, welfare, safety and economic security of the citizens of the state are promoted through the development and/or retention of employment opportunities. A local development authority must be the applicant for an EDGE application and the application must be supported by a recommendation letter from a state agency, typically the Georgia Department of Economic Development.

Equity Fund (OneGeorgia Authority)

Application Period: ongoing

Type: Grant or Loan

The purpose of the Equity Fund is to provide a program of financial assistance that includes grants, loans and any other forms of assistance to finance activities that will assist applicants in promoting the health, welfare, safety, and economic security of the citizens of the state through the development and retention of employment opportunities in areas of greater need.

Regional Economic Business Assistance (REBA)

Application Period: ongoing

Type: Grant or Loan

REBA is an incentive program that is used to help "close the deal" when companies are considering Georgia and another state or country for their location or expansion. REBA funds may be used to finance various fixed-asset needs of a company including infrastructure, real estate acquisition, construction, or machinery and equipment. A local development authority must be the applicant for a REBA application and the application must be supported by a recommendation letter from a state agency, typically the Georgia Department of Economic Development.

Employment Incentive Program

Application Period: ongoing

Type: Loan

The Employment Incentive Program (EIP) is a financing program that may be used in conjunction with traditional private financing for economic development projects resulting in employment of low- and moderate-income persons.

Many types of public infrastructure projects, or loans to for-profit companies, can be financed with EIP funding. Projects creating opportunities for low- and moderate-income persons (at least 51% of total jobs created), greater job security, better working conditions, job training, enhancement of workplace skills, advancement opportunities, and benefits receive the greatest consideration.

Immediate Threat and Danger Program (CDBG)

Application Period: ongoing

Type: Grant

The Immediate Threat and Danger Program provides 50% matching funds for community development activities having a particular urgency when existing conditions pose a serious and immediate threat to the health or welfare of the community. Local funds must comprise at least 10% of project costs. Funding for this program comes from the state's annual Community Development Block Grant (CDBG) program. Applicants can apply for \$50,000 and DCA reserves \$200,000 for "major disasters."

CDBG Section 108 Loan Guarantee Program

Application Period: ongoing Type: Loan Guarantee

The CDBG Section 108 Loan Guarantee Program is an economic and community development financing tool authorized under Section 108 of Title I of the Housing and Community Development Act of 1974, as amended. The program is a method of assisting non-entitlement local governments with certain unique and large-scale economic development projects that cannot proceed without the loan guarantee. In order to be eligible a project must meet all applicable CDBG requirements and result in significant employment and/or benefit for low and moderate income persons. Projects that are eligible for financing under existing federal, state, regional or local programs will generally not be considered for guarantee assistance unless the programs would fail to fully meet a project's need.

Unlike the traditional CDBG or EIP Program, the Section 108 Program does not operate through assistance from the Department of Community Affairs (DCA). Rather, funds are raised through DCA's "Pledge of Grants" to the U.S. Department of Housing and Urban Development (HUD) in order to obtain a federal guarantee of notes issued by the local government. The federally guaranteed notes are sold into private markets through public offerings conducted by HUD. By approving the project, the State pledges its future CDBG funds as the ultimate repayment source should a Section 108 loan default. The State's participation in the Section 108 program does not involve a pledge of Georgia's full faith and credit nor does it commit any funding to the local government. HUD makes the ultimate approval or denial of the federal guarantee.

Annual CDBG Competition

Application Period: through 6/4/21

Type: Grant

The Community Development Block Grant Program (CDBG) provides funding to assist a wide range of eligible activities, including housing improvement projects, public facilities such as water and sewer lines, buildings such as local health centers or head start centers, and economic development projects. All projects must substantially benefit low and moderate income persons. The maximum amount available per applicant is \$750,000 for Single-Activity during regular competition and \$1,000,000 for Multi-Activity during regular competition.

Local Match Requirements - Annual Competition:

- Grants up to \$300,000, or grants for single activity housing projects no matching funds required.
- Grants of \$300,001 to \$750,000 5% local matching funds required.
- Grants of more than \$750,001 10% local matching funds required.

Eligible applicants are units of general local government, excluding metropolitan cities, urban counties, and units of government eligible to participate in the urban counties or metropolitan cities programs of the U.S. Department of Housing and Urban Development. Eligible applicants selected for funding will be those having the greatest need as evidenced by poverty and per capita income and whose applications most adequately address the needs of low and moderate income persons and have the greatest impact.
