RD Rural Microentrepreneur Assistance Program (RMAP)

Type: Loan or Grant Deadline: 6/30/2024

This program is designed to provide loans and grants to Microenterprise Development Organizations (MDOs) to:

- Help microenterprises startup and growth through a Rural Microloan Revolving Fund.
- Provide training and technical assistance to microloan borrowers and micro entrepreneurs.

Type: Grant or Loan

Deadline: 4/12/2024, next deadline is 7/12/2024

The purpose of the Equity Fund is to provide a program of financial assistance that includes grants, loans and any other forms of assistance to finance activities that will assist applicants in promoting the health, welfare, safety, and economic security of the citizens of the state through the development and retention of employment opportunities in areas of greater need. # Georgia Department of Community Affairs (DCA)

Employment Incentive Program

Type: Loan

Deadline: Ongoing

The Employment Incentive Program (EIP) is a financing program that may be used in conjunction with traditional private financing for economic development projects resulting in employment of low- and moderate-income persons. Many types of public infrastructure projects, or loans to for-profit companies, can be financed with EIP funding. Projects creating opportunities for low- and moderate-income persons (at least 51% of total jobs created), greater job security, better working conditions, job training, enhancement of workplace skills, advancement opportunities, and benefits receive the greatest consideration.

Fire Prevention and Safety (FP&S)

Type: Grant

Deadline: 4/12/2024

The Fire Prevention and Safety (FP&S) Grants are part of the Assistance to Firefighters Grants (AFG) and support projects that enhance the safety of the public and firefighters from fire and related hazards. The primary goal is to reduce injury and prevent death among high-risk populations. In 2005, Congress reauthorized funding for FP&S and expanded the eligible uses of funds to include Firefighter Safety Research and Development.

Staffing for Adequate Fire and Emergency Response (SAFER)

The Staffing for Adequate Fire and Emergency Response Grants (SAFER) was created to provide funding directly to fire departments and volunteer firefighter interest organizations to help them increase or maintain the number of trained, "front line" firefighters available in their communities. Community Policing Development (CPD) funds are used to develop the capacity of law enforcement to implement community policing strategies by providing guidance on promising practices through the development and testing of innovative strategies; building knowledge about effective practices and outcomes; and supporting new, creative approaches to preventing crime and promoting safe communities.

An essential community is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial, or business undertakings.

#### RD Special Evaluation Assistance for Rural Communities and Households (SEARCH)

Type: Technical Assistance

#### Deadline: Ongoing

This program helps very small, financially distressed rural communities with predevelopment feasibility studies, design and technical assistance on proposed water and waste disposal projects. Eligible applicants include public bodies, non-profits, and federally recognized tribes. Eligible areas include rural areas with no more than 20,000 residents and a median household income below 80% of the state non-metropolitan median household income. #### **RD Emergency Community Water Assistance Grants**

#### Type: Grant

#### Deadline: Ongoing

This program helps prevent damage or restore households and business' access to clean, reliable drinking water in eligible rural areas and towns following natural disasters (including drought, floor, earthquake, tornado, hurricane, disease outbreak, chemical spill/leak/seepage, and more). A federal disaster declaration is not required. Funding can improve the natural environment and encourage manufacturers and other businesses to locate or expand operations. Applications for this program are accepted year-round. Eligible applicants include public bodies, non-profits, and federally recognized tribes. Eligible areas include rural areas with no more than 10,000 residents.

# Safe Streets and Roads for All (SS4A)

#### Type: Grant

Deadline: Deadline #1 4/4/2024; Deadline #2 5/16/2024; Deadline #3 8/29/2024 The program supports the development of a comprehensive safety action plan that identifies the most significant roadway safety concerns in a community and the implementation of projects and strategies

to address roadway safety issues. The SS4A program provides funding for two types of grants:

- Planning and Demonstration Grants provide Federal funds to develop, complete, or supplement a comprehensive safety action plant. The goal of an Action Plan is to develop a holistic, welldefined strategy to prevent roadway fatalities and serious injuries in a locality, Tribe, or region.
- Implementation Grants provide Federal funds to implement projects and strategies identified in an Action Plan to address a roadway safety problem. Projects and strategies can be infrastructure, behavioral, and/or operational activities. Implementation Grants may also include demonstration activities, supplemental planning, and project-level planning, design, and development.

Economic Adjustment Assistance Program

Deadline: Ongoing

Type: Grant

The Economic Development Administration's (EDA) Economic Adjustment Assistance (EAA) program provides funding for technical, planning, and public works and infrastructure projects in regions experiencing adverse economic changes that may occur suddenly or over time. These adverse impacts may result from a steep decline in manufacturing employment following a plant closure, changing trade patterns, catastrophic natural disaster, a military base closure, or environmental changes and regulations.

#### Transportation Infrastructure Finance & Innovation Act (TIFIA)

Type: Loan

Deadline: Ongoing

The Transportation Infrastructure Finance and Innovation Act (TIFIA) program provides credit assistance for qualified projects of regional and national significance. Many large-scale, surface transportation projects - highway, transit, railroad, intermodal freight, and port access - are eligible for assistance. Eligible applicants include state and local governments, transit agencies, railroad companies, special authorities, special districts, and private entities. The TIFIA credit program is designed to fill market gaps and leverage substantial private co-investment by providing supplemental and subordinate capital. Each dollar of Federal funds can provide up to \$15 in TIFIA credit assistance and support up to \$50 in transportation infrastructure investment.

Transportation Infrastructure Finance & Innovation Act (TIFIA) - Rural Project Initiative (RPI) Type: Loan

#### Deadline: Ongoing

The Rural Project Initiative is aimed at helping improve transportation infrastructure in America's rural communities. Eligible projects include: Roads, bridges and tunnels; Transit systems including infrastructure, bus and train stations, and buses and passenger rail vehicles and facilities; Intermodal connectors; Pedestrian and bicycle infrastructure; Freight transfer facilities; Sea and inland waterway ports, and even; Airports - under certain circumstances. For the purposes of this initiative, a rural project is one that is located outside of an urbanized area with a population greater than 150,000 individuals as determined by the Bureau of Census.

The LMIG program will allow local governments greater flexibility and quicker project delivery while allowing us to effectively administer the program with a reduced workforce and new funding match requirements.

Hometown Grants are given every quarter to up to 25 small towns. Apply for funding to support a community project of your choice, like revitalizing or repurposing a historic structure, creating a downtown asset or destination, or improving a space where friends and neighbors gather. Projects that are "shovel-ready" and add to a sense of place or could lead to further investment are of particular interest. T-Mobile will award up to \$50,000 for shovel-ready projects. Applicant's proposal must include plans, budget, timeline, anticipated impact, and up to five letters of support. #### Equity Fund – Rural Workforce Housing Initiative (One Georgia Authority)

#### Type: Grant or Loan

Deadline(s): 4/12/2024 for June award announcement; 7/14/2023 for September award announcement With this opportunity, there is financial assistance available via the Equity Fund available in the form of grants and loans for activities that result in housing that meets the needs of working families and others who may consider relocating to a community for employment reasons. Workforce housing funds will be awarded on a competitive basis to projects that demonstrate an ability to address:

- Ongoing workforce housing needs, as identified by a recent housing study;
- Difficulty satisfying workforce needs in communities or regions with low unemployment; or
- A community or regional commitment to expand and improve existing housing stock.

This initiative is intended to provide a flexible funding source to support any eligible activity that results in workforce housing. Examples of such activities include essential community infrastructure specifically needed to support new housing development, land acquisition (subject to public ownership requirements), and construction finance for workforce housing.

Grantees will be expected to demonstrate transformational change in workforce housing. OneGeorgia funds are offered to support housing affordability; therefore, resulting cost savings must contribute to the affordability of the per unit purchase price or rent extended to families who ultimately benefit from the activity.

Infrastructure grants are limited to no more than \$2,500,000 per application and development. Construction finance is limited to no more than \$1,000,000 per applicant and development. The Authority reserves the right to fund, in whole or in part, any, all, or none of the applications submitted.



Applications for less than \$250,000 will not be accepted; however, the Authority reserves the ability to waive minimum and maximum funding limits at its discretion.

Matching: Applications are expected to leverage other sources of funding – private debt or equity, philanthropic support, or other public funds. For applicants seeking assistance with infrastructure, there is no prescribed match requirement; however, leverage will factor into an application's overall competitiveness.

Eligible Applicants: Units of general-purpose local government (e.g., city, county, consolidated government), as well as local, regional, and state authorities, generally in partnership with a housing developer, are eligible to apply. The OneGeorgia Authority will also consider offering loans to private developers, including not-for-profits and community housing development organizations, to further the objectives of this initiative. Applicants may only submit applications within OneGeorgia eligible and conditionally eligible counties.

#### CDBG Section 108 Loan Guarantee Program

Type: Loan Guarantee

Deadline: Ongoing

The CDBG Section 108 Loan Guarantee Program is an economic and community development financing tool authorized under Section 108 of Title I of the Housing and Community Development Act of 1974, as amended. The program is a method of assisting non-entitlement local governments with certain unique and large-scale economic development projects that cannot proceed without the loan guarantee. In order to be eligible a project must meet all applicable CDBG requirements and result in significant employment and/or benefit for low and moderate income persons. Downtown Development Revolving Loan Fund (DDRLF)

Type: Grant to Lenders (grants for DDAs to lend to businesses)

#### Deadline: Ongoing

The purpose of the Downtown Development Revolving Loan Fund (DD RLF) is to assist cities, counties and development authorities in their efforts to revitalize and enhance downtown areas by providing below-market rate financing to fund capital projects in core historic downtown areas and adjacent historic neighborhoods where DD RLF will spur commercial redevelopment. Eligible applicants under this program shall be municipalities with a population of 100,000 or less, counties with a population of 100,000 or less proposing projects in a core historic commercial area, and development authorities

proposing projects in a core historic commercial area in municipalities or counties with a population of 100,000 or less. The ultimate user of funds may be a private business or a public entity such as a city or development authority.

#### Redevelopment Fund (RDF)

Type: Grant or Loan (Flexible Financial Assistance)

#### Deadline: Ongoing

Recognizing that redevelopment projects can be the most challenging economic and community development projects a local government may undertake, the Redevelopment Fund (RDF) was created as a set-aside of Georgia's non-entitlement CDBG Program. The RDF provides local governments access to flexible financial assistance to help them implement projects that cannot be undertaken with the usual public sector grant and loan programs. The RDF finances locally initiated public/private partnerships to leverage investments in commercial, downtown, industrial redevelopment, and revitalization projects that may not proceed otherwise. Unlike other DCA CDBG programs, the RDF uses the CDBG national objective of "eliminating slums or blight." The Downtown Renaissance Strategic Visioning and Planning Process assists downtowns through the creation of a community-supported vision, plan, and implementation program. The RSVP is both a downtown master planning process and a downtown planning document that illustrates the community's vision for the future and provides the steps to get there. Driven by a robust public input process that seeks the participation of all community members, RSVPs help local governments and community partners prioritize top downtown issues and work to establish a consensus around what must be achieved in the short and long-term.

# National Endowment for the Humanities Public Impact Projects at Smaller Organizations

#### Type: Grant

Deadline: Option Draft due 5/8/2024; Final Deadline 6/12/2024

Public Impact Projects at Smaller Organizations (PIP) helps small and mid-sized museums and cultural organizations build their interpretive skillset and develop interpretive public humanities programming. The goal of PIP is to help you and your organization identify potential interpretive content based on your collections, increase the interpretive skills of staff and/or volunteers, and/or launch interpretive public programs that attract new audiences.

Successful projects should demonstrate how the humanities matter to audiences and communities. Strong public humanities interpretation is the key factor driving funding decisions under PIP. NEH's definition of the humanities is wide-ranging and includes fields like history, art history, ethnomusicology, archaeology, anthropology, literature, philosophy, and other areas that offer critical examination of human history and culture (see A2. Background). # Georgia Department of Community Affairs (DCA)

CDBG Immediate Threat and Danger Program (ITAD)

Type: Grant

Deadline: Ongoing

The Immediate Threat and Danger Program provides 50% matching funds for community development activities having a particular urgency when existing conditions pose a serious and immediate threat to the health or welfare of the community. The ITAD Program is intended to address situations which are urgent and unique. These situations should typically occur due to state or federally declared disasters. Local funds must comprise at least 10% of project costs. Funding for this program comes from the state's annual Community Development Block Grant (CDBG) program. Applicants can apply for \$50,000 and DCA reserves \$200,000 for "major disasters."

The CDBG-CV program originated from the CARES Act of 2020, enacted to provide relief in response to the COVID-19 pandemic. An allocation was made to states to "prevent, prepare for, and respond to" COVID-19 through funding from the Department of Housing and Urban Development (HUD). In total, Georgia received \$82,850,707 from HUD for the CDBG-CV program, including administration. Generally speaking, all typical federal requirements associated with CDBG funding apply to grantees and subgrantees. In addition to the CDBG regulations, DCA and its subgrantees must adhere to all additional requirements outlined in Federal Register Notice FR-6218-N-01.

State Small Business Credit Initiative (SSBCI)

The Small Business Jobs Act of 2010 (the "Act") became law in the fall of 2010. The Act created the State Small Business Credit Initiative, funded with \$1.5 billion to strengthen state lending programs that support small businesses and manufacturers. Of the total amount funded, Georgia was allocated \$48,024,748. Currently, Georgia's SSBCI offers two programs.

- 1. GA LPP (Georgia Loan Participation Program) is a program where the State purchases a participation of up to 25% of an approved loan, for loans ranging from \$100,000 to \$5,000,000.
- 2. Georgia SBCG (Small Business Credit Guaranty) is a 50% loan guaranty program with a current maximum loan amount of \$400,000 with a \$200,000 guarantee.
